Volume 33 of the **BIBLIOGRAPHY OF BIOETHICS** ready to ship in September 2007!

The Kennedy Institute of Ethics at Georgetown University announces the publication of Volume 33 of the **Bibliography of Bioethics**. Prepared by a team of reference librarians, bibliographers and researchers, the **Bibliography of Bioethics** remains the most comprehensive reference source to literature on the ethical, legal, and public policy issues of health care, biomedical research, and biotechnology; the latest volume in the annual series contains 8,779 recent references to journal articles, legal and government documents, books, book chapters, audiovisuals, and news reports. LeRoy Walters, Ph.D., the Joseph P. Kennedy, Sr., Professor of Christian Ethics; Tamar Joy Kahn, M.L.S., Senior Bibliographer, Bioethics Information Retrieval Project; and Doris Mueller Goldstein, M.A., M.L.S., Director of Library and Information Services for the National Reference Center for Bioethics Literature, edited this volume.

Entries in the **Bibliography** are selected from the extensive holdings of the National Reference Center for Bioethics Literature. Volume 33 has 848 pages with records organized under 78 major subject headings. Two easy-to-use subject indexes to the periodical and monograph literature cover such topics as advance directives, animal experimentation, assisted suicide, cloning, confidentiality, death and dying, euthanasia and allowing to die, genetic screening, human experimentation, informed consent, nanotechnology, organ and tissue transplantation, patents, quality and value of life, reproductive technologies, resource allocation, and treatment refusal. Some topics have subheadings for legal aspects, religious or philosophical aspects, or special populations. Classification numbers at the end of each citation represent additional topics covered by the publication. An author index provides alternate access to the periodical literature and abstracts augment citations to articles from selected journals. Comprehensive acquisition information is provided for all recently-acquired monographs, which are listed both by subject and by title.

The **Bibliography** is a valuable asset in the cross-disciplinary field of bioethics. It serves as a resource that gathers information from diverse sources, a variety of indexes, and across a range of topics and publication types to provide the user with broad access to scholarship in the field.

The Kennedy Institute of Ethics began the annual series in 1975 and has published the bibliography since 1985. The new volume is available for \$70 to US and Canadian customers and \$80 to overseas customers from the Kennedy Institute of Ethics, Georgetown University, Washington, DC 20057.

The BIBLIOGRAPHY is the most comprehensive published reference source available in the world for locating literature about the ethical, legal and public policy aspects of health care and biomedical research. Volume 33 contains:

- 848 pages, hardcover binding
- 8,779 new citations to the literature of bioethics
 - 6,381 journal articles
 - 1,067 essays in books
 - 432 newspaper articles
 - 128 reports and other grey literature
 - 109 legal documents
 - 78 major subject headings
 - 662 records for books, monographs, audiovisuals, special issues of journals, and new periodical subscriptions
- And government documents and unpublished documents.

Easy access to topics that are arranged alphabetically by indices. Subject headings include: Abortion, Advance Directives, Animal Experimentation, AIDS, Assisted Suicide, Cloning, Confidentiality, Death and Dying, Euthanasia and Allowing to Die, Genetic Screening, Genetics, Human Experimentation, Informed Consent, Mental Health Therapies, Nursing Ethics and Philosophy, Organ and Tissue Transplantation, Professional Professional Relationship, Religious Perspectives, Reproductive Technologies, Research Ethics, Resource Allocation, and War and Terrorism.

The periodical literature is indexed by subject and by author. Abstracts are available for journal articles from selected journals. Monographic literature is indexed by subject and by title.

The Kennedy Institute of Ethics, Georgetown University, has published the work since 1985.
